1) ENTRIES: EV110: \$300; EV100: \$275; EV90: \$255; EV85: \$235; EV78: \$210; EV60: \$190. Includes HST, EC drug fee, \$5 OEA levy. All entries please add \$15 EC levy. **Entries are only accepted when payment is received.** Enter at www.evententries.com (preferred) or by email to the Secretary. Payment by closing date (CD) by e-transfer to stevenscreekshows@gmail.com (indicate name of horse and rider and division on the e-transfer; if password required use: eventing). Please email current memberships (Ontario: EC, OE & OEA; Quebec: EC, Cheval QC & ACCC-Q) and negative Coggins (within 12 months) to Secretary at time of entry. Entries at EV100 & EV110 must email a **digital Horse Recording** at time of entry. **LATE FEE: \$30 (+ HST)** for entries and/or changes after the CD. **REFUNDS:** Before CD less a \$50 fee; no refunds after CD. *The Organizer reserves the right to add, delete, combine or cancel divisions as entries warrant. If the competition is cancelled for any reason after it commences, no refunds will be issued.*

2) TENTATIVE SCHEDULE: Sept. 16, noon: course open. Sept. 17, 8:00 AM: dressage; 9:30 AM: show jumping; 10:30AM: cross country. Start times posted on the SCF and OEA websites and SCF FB page.

3) OFFICIALS: TD: Sue Ockendon; CD: John Williams (FEI, USEF); Judge (SJ): Eileen Gilbert (USEF & EC'R'). Dressage: Marianne Fizet, TBC.

4) STABLING: Limited on site. \$85 (+HST) per night. Initial straw bedding included. \$20 (+HST) surcharge for shavings. Hay available to purchase on site. Contact Secretary to reserve.

5) DRESSAGE: (EC 2023 tests) EV110: EV110 Test; EV100: EV100 Test 1; EV90: EV90 Test 2; EV85: 2023 EV85 Test 2; EV78 & EV 60 : EV85 Test 1. All levels: 20x40 sand rings.

6) CROSS COUNTRY (approx.): EV110: 3000m@520mpm; EV100:2500m@450mpm; EV90: 2000m@400mpm; EV85: 1800m@350mpm; EV78: 1500m@300mpm; EV60: 900m@250mpm. Encouraging open courses with a large watercomplex, two banks and natural and reveted ditches. EV60 straightforward logs. Excellent footing on mature turf hay fields and visibility of full courses for coaches and spectators.

7) AWARDS: Ribbons to 8th. Prizes for top placings in all divisions.

8) ACCOMMODATIONS: Manotick, Kemptville, Kanata and Nepean.

9) DIRECTIONS: From Hwy 416 North or South: Exit Roger Stevens Drive, go east towards Kars for ½ km, first left (north) on Second Line Rd. Go 1 km. First farm on right immediately after small bridge. **Hwy 417 from Montreal:** Exit Hwy 417 at Boundary Rd turn left, after a few kms, turn right on Cartwright St (6A). Continue for several kms. Cartwright St becomes Victoria St and then Snake Island Rd. Continue to the end and at the T-junction, bear right on Nixon Dr which soon becomes Roger Stevens Dr. Just before Hwy 416, turn right on Second Line Rd. 1 km. 1st farm on right after small bridge.

10) OTHER INFORMATION: Canteen and farrier on site. Paramedic during jumping phases. Vet on call. XC pinnyholders required. Competitors required to print course maps & numbers from SCF website. Dogs must be leashed.
