**1) ENTRIES:** EV110: \$325; EV100: \$290; EV90: \$270; EV85: \$250; EV78: \$220; EV60: \$200. *Includes HST, EC drug fee, \$5 OEA levy.* All entries please add \$15 EC levy. **Entries are only accepted when payment is received.** Enter at [www.evententries.com](http://www.evententries.com) (preferred) or by email to the Secretary. Payment by e-transfer to

Please email current memberships (Ontario: EC, OE & OEA; Quebec: EC, Cheval QC & ACCC-Q) and negative Coggins (within 12 months) to Secretary at time of entry. Entries at EV100 & EV110 email a **Digital Horse Recording** at time of entry.

**LATE FEE: \$30(+HST)** for entries or changes after the CD. **REFUNDS:** Before CD less \$50; no refunds after CD. All scratches must be in writing. *The Organizer reserves the right to add, delete, combine or cancel divisions as entries warrant. If the competition is cancelled for any reason after it commences, no refunds will be issued.*

**2) TIME SCHEDULE:** July 27, noon: course open. July 28, 8:00 AM: dressage; 9:30 AM: show jumping; 10:30 AM: cross country. Start times posted on the SCF website and FB page and the OEA website ([www.ontarioeventing.com](http://www.ontarioeventing.com)).

**3) OFFICIALS:** TD: John Williams (FEI, USEF); CD(XC): Dylan Barry; CD(SJ): Teddie Laframboise; Judges: Gail Prest (SJ); Dressage: Marianne Fizez; TBC.

**4) STABLING:** Limited on site. \$85 (+HST) per night. Initial bedding included. \$20 (+HST) surcharge for shavings. Hay is available to purchase on site. Contact the Secretary to reserve.

**5) DRESSAGE:** EV110: EC 2023 EV110 Test 1; EV100: EC 2023 EV100 Test 1; EV90: EC 2023 EV90 Test 1; EV85: EC 2023 EV85 Test 2; EV78: EC 2023 EV85 Test 1; **EV60:** EC 2023 EV85 Test 1. **Arenas:** All levels 20x40m sand rings.

**6) CROSS COUNTRY (distances approx.):** EV110 3000m@520 mpm; EV100 2500m@450 mpm; EV90 2000m@400mpm; EV85 1800m@350 mpm; EV78 1500m@300 mpm; EV60 900m@250 mpm. Encouraging open courses with a large watercomplex, two banks and natural and riveted ditches. EV60: straightforward logs. Excellent footing on rolling to flat mature turf hay fields and visibility of full courses for coaches and spectators. New jumps and road-crossing complex planned for 2024.

**7) AWARDS:** Ribbons to 8<sup>th</sup>. Prizes for top placings in all divisions.

**8) ACCOMODATIONS:** Manotick, Kemptville, Kanata and Nepean.

**9) DIRECTIONS: From Hwy 416 North or South:** Exit Roger Stevens Drive, go east towards Kars for ½ km, first left (north) on Second Line Rd. Go 1 km. First farm on right immediately after small bridge. **Hwy 417 from Montreal:** Exit Hwy 417 at Boundary Rd turn left, after a few kms, turn right on Cartwright St (6A). Continue for several kms.

Cartwright St becomes Victoria St and then Snake Island Rd. Continue to the end and at the T-junction, bear right on Nixon Dr which soon becomes Roger Stevens Dr. Just before Hwy 416, turn right on Second Line Rd. 1 km. 1<sup>st</sup> farm on right after small bridge.

**10) OTHER INFORMATION:** Canteen and farrier on site. Medic during jumping phases. Vet on call. XC pinnyholders are required. Competitors required to print course maps and numbers. Dogs must be leashed. *NCHTA Point Qualifier.*
