- 2) **REFUNDS:** Before CD, less \$30 admin fee. After CD, with vet or medical certificate, less \$30 admin fee. Late fee \$50. Change fee \$30. **Note:** Please fill out competition/clinic/division **history** on entry form.

- 7) **DRESSAGE: (2023 EC tests):** EV 110 - EV110 Test 2, EV100 – EV100 Test 1, EV90 – EV90 Test 2, EV85 – EV85 Test 2, EV75 - EV85 Test 1, EV60 – ICE Test B. 20x40 grass rings.
- 8) **CROSS COUNTRY:** EV110 - 2800m @ 500 mpm, EV100 - 2500m @ 450mpm, EV90 - 2200m @ 400 mpm, EV85 - 2000m @350 mpm, EV75 - 1800m @ 325mpm, EV60 - 1600m @325 mpm. Rolling open terrain, spectator friendly.
